Trafficking in human beings is a widespread phenomenon difficult to trace

Millions of people are trafficked every year for the purpose of forced labour, sexual exploitation or other forms of exploitation which violate the person's dignity, integrity and human rights. Statistics show that recruitment occurs predominantly in the African continent, Southeast Asia, and Eastern Europe. The exploitation tends to be consumed in Europe. Moreover, other conditions and systemic factors make migrants across Europe at risk of exploitation and trafficking. Due to the COVID-19 Pandemic, national lockdowns have exacerbated the already precarious situation facing survivors, through the further limitations on their movement and barriers to accessing help, services and fleeing. At the same time, the closure of schools had further exposed children to the risk of being exploited or trafficked.

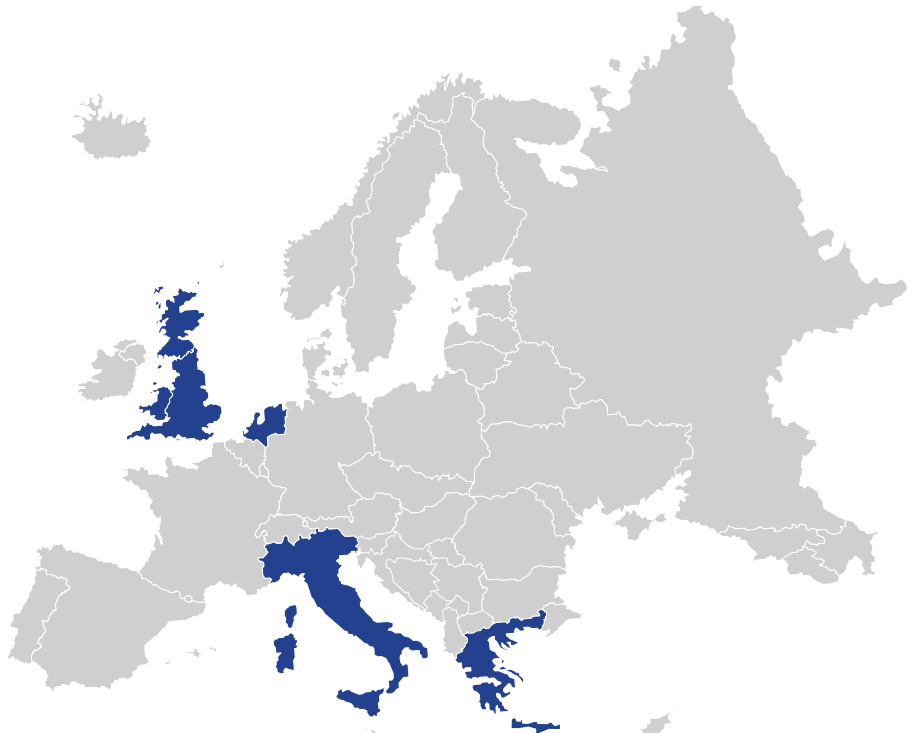
